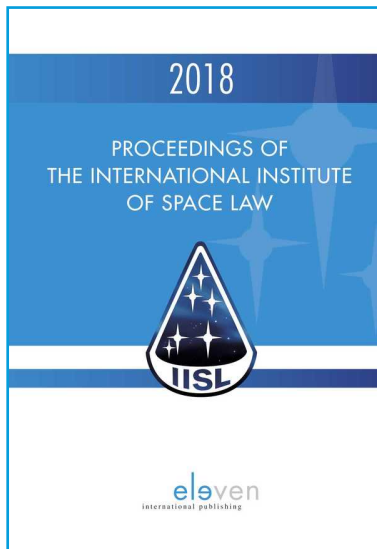


## Proceedings of the International Institute of Space Law 2018
